## **ABOUT ABSL MOLDOVA**

- The Association of Business Service Leaders in the Republic of Moldova is a member organization representing the voice of the outsourcing industry in the Republic of Moldova.
- Founded in July 2021, it serves as a driving force in fostering innovation and growth within the business outsourcing industry in Moldova.
- The Association is dedicated to unlock the full potential of Moldova's modern business services sector and creating a favorable environment to its sustainable development.
- Our vision is to establish Moldova as a leading global business services hub, recognized for its exceptional talent, innovative solutions and favorable business climate, promoting sustainable economic progress and prosperity for all stakeholders.

# **BSS IN MOLDOVA**

- Moldova's service exports have doubled in just four years, reaching \$2.4 billion in 2023. This significant growth translates into tens of thousands of well-paid jobs in the country.
- Today, service exports account for 42% of Moldova's total exports, and we're on track to exceed 50% in the coming years.
- Business services is one of the top growing services in 2023, focusing on managerial and professional consulting: up 31% from 2022, reaching \$246 million.
- Following governmental incentives in the form of fiscal benefits to the IT sector, was observed a significant acceleration in growth, resulting in a pronounced gap between Business Service Services (BSS) and Information Technology Outsourcing (ITO).
- The expansion of the BSS industry has a potentially broader impact on employment compared to the ITO sector.
- Moldovan employees exhibit competence, motivation, and adaptability, with monthly wages in the BSS ranging from approximately 475 EUR to 1100 EUR, depending on the level of job complexity.



- BPO is an emerging sector, which has the potential of engaging larger numbers of educated and multilingual young people, decent salaries and opportunities for international level professional development.
- In Moldova's BPO sector, alongside contact centers, there's a growing trend towards high-value, sophisticated services:
  - · Customer Support Services;
  - · Legal outsourcing;
  - Accounting/Payroll;
  - · Marketing;
  - · Banking;
  - · HR outsourcing;
  - · IT and R&D support;
  - · Financial analysis;
  - · Engineering;
  - Logistics;
  - · Retail, etc.

# MOLDOVA EMERGING DESTINATION

Moldova offers a great combination of beneficial factors, that will lead to higher value-added jobs in the long term:

- excellent language skills and a highly educated labor force;
- proximity in both culture and distance from the European market;
- an advanced and reliable ICT infrastructure, an openness from the Government to support the sector;
- competitive operational costs;
- 7% Tax Special Government incentive on IT Park, for the BPO eligible activities;
- multilingual workforce 14,000 new graduates per year;
- strong relevant university programs with over 57,000 students enrolled in Bachelor's and Master's programs;
- 24,380 students specializing in Business, Law, and Administrative studies;



ABSL obtained an important achievement of expanding eligible activities for BPO companies in Moldova IT Park, which can benefit from the 7 % Single Rate.

Beginning with 12.02.2024, Moldova IT Park facilitates the operation of:

- 1. call centers (82.20), including those based on any technology/channel of customer communication (contact center), exclusively for export,
- 2. other labor supply services (78.30), exclusively for export.

The tax facility MITP residents enjoy is unique worldwide, offering the most optimal level of taxation in Central and Eastern Europe.


